ILCHESTER LECTURES ON GREEKO-SLAVONIC LITERATURE**AND ITS RELATION TO THE
FOLK-LORE OF EUROPE DURING THE MIDDLE AGES.**

WITH TWO APPENDICES AND PLATES.

The intention of these Ilchester Lectures is to give a sketch of the origin and development of the Slavonic Nations in the Balkan Peninsula, and of the old Slavonic Literature which became the basis of the literature and of the Folk-lore of the various peoples belonging to the Greeko-orthodox Church—such as the Bulgarians, Servians and Russians, and also of the non-Slavonic Roumanians. The old Slavonic literature, based upon the Byzantine, is likewise a reflex of this less-known portion of the Greek literature, and contributes to a better knowledge of it.

Great stress is further laid upon the relation, which until now has passed unobserved, existing between the Greeko-Slavonic literature of East Europe and of the Latin of West Europe, and more especially upon the influence exercised by the former upon the Folk-lore of Europe, through the medium of the heretical sects which originated in Asia, which were very powerful in Bulgaria, and which gradually spread throughout Europe.

Specimens of the old Slavonic literature and of its further development are here given in literal translations. They prove that the poetical and apocryphal Christian literature enters as one of the principal elements in the composition of modern Folk-lore: a fact which has to the present not been noticed, and which upsets many hitherto prevailing mythological theories and speculations.

There are two appendices added to these lectures: the first deals with the two Slavonic alphabets, the Cyrillian and the Glagolitic; whilst the second treats of the "Bible Historale" and the "Bible of the Poor."

Our Muhammadan author does not, like Tacitus, portray the infancy of a great nation. At his time the dome of Indian civilization had long ago been finished both at large and in every detail, its initial stages had long ago faded away from the memory of the nation. Like Herodotus in Babylonia and Egypt, Albérŭnĭ found in India an exotic civilization as strange and marvellous as it was perfect in its way, but on the eve of being encroached upon by foreign invaders. The time of Albérŭnĭ, that of the great Mahmŭd of Ghazna, is the end of the political independence of India, and the inauguration of Muhammadan rule, in fact the beginning of a historic development which terminated in the establishment of British rule throughout the whole of the peninsula. Already before Mahmŭd, foreign invaders had conquered parts of India, but they again had, in their turn, been conquered by Indian civilization, so as to become Indians by the same process of assimilation by which the Bulgarians, originally a Turkish tribe, have become Slavonians, and the great tribe of the Ghilzai in Afghanistan, who originally were Turks, have become Afghans. The Muhammadans, however, remained in India what they were when they entered. Though adopting the language of their subjects, and many of their customs, they remained in law and religion, foreigners to the country. India as sketched by Albérŭnĭ, is India at the close of its national existence.
