

POPULATION AND SOCIETY IN TWENTIETH CENTURY FRANCE

Colin Dyer

The story of the people of France in the present century must certainly count among the most eventful of any population at any time. Taking as his starting point France on the eve of the Great War, the author unfolds his story from the viewpoint of a social historian, and uses a fascinating selection of statistical and documentary material to show how the French people have suffered, changed, endured foreign occupation and, since 1945, rebuilt their nation. The use of many tables, maps and diagrams as well as eye-witness accounts and contemporary interviews, gives an entirely new dimension to the history of France. Whether he is talking about the ravages of the Great War, the problems of living in German-occupied territory or of absorbing a large immigrant population, Colin Dyer writes perceptively and with great sympathy and understanding of the French people.

Revolution and Urban Politics in Provincial France

Troyes and Reims, 1786–1790

Lynn A. Hunt. Troyes and Reims experienced the Revolution in strikingly different ways. The author attributes these differences to a combination of economic, social, and political factors that shaped the structure of local politics before and during 1789, and that go far toward explaining the wide variety of local reactions throughout France to the fall of the Old Regime. At the same time, underlying similarities in the two towns' reactions to the events of 1789 help to suggest what was truly national about the Revolution. \$11.50

Race and Class in Colonial Oaxaca

John K. Chance. The central concern of this study of changing social stratification in the city of Oaxaca is the development and function of the *sistema de castas*—the system of ranked ethnic statuses, encoded in Spanish law, that emerged in response to the growth of the New World's racially mixed population. Rejecting previous interpretations of the system, the author uses a wealth of new anthropological and historical data to demonstrate that it was far from static throughout the three centuries of colonial rule, and much less rigid than commonly supposed. \$14.00

L. H. Gann & Peter Duignan. The first book in a series dealing with the social structure of the European colonial services in Africa, this work examines Germany's military and administrative personnel in the colonies of German East Africa, South-West Africa, Cameroun, and Togo: their performance on the scene, their educational and class background, their ideology, their continuing ties with the homeland, and their subsequent careers. \$17.50

Two copies of each contribution, preferably accompanied by a stamped, addressed envelope, should be submitted. Both text and footnotes should be clearly typed with double spacing and wide margins; footnotes should appear on separate pages at the end of the article. Illustrations may be included by arrangement with the editors.

Contributors will receive 50 offprints. Any additional offprints must be ordered on receipt of the first proof.
