Roderick T. Long is Assistant Professor of Philosophy at the University of North Carolina at Chapel Hill. He received his Ph.D. in philosophy from Cornell in 1992. He has published in *Utilitas* and *Social Philosophy and Policy*, and has recently completed a book tentatively titled *Aristotle on Fate and Freedom*. His current project is a study of Socrates' theory of moral psychology in the Socratic works of Plato and Xenophon.

Loren E. Lomasky is Professor of Philosophy at Bowling Green State University. He was educated at Michigan State University, Harvard University, and the University of Connecticut, and has taught at the University of Minnesota, Duluth, and at the University of Connecticut at both the Hartford and Storrs branches. He is the author of *Persons, Rights, and the Moral Community* (1987), the coauthor, with Geoffrey Brennan, of *Democracy and Decision: The Pure Theory of Electoral Preference* (1993), and the coeditor with Brennan of a volume of essays titled *Politics and Process: New Essays in Democratic Theory* (1989).

Alexander Rosenberg is Professor of Philosophy and Director of the University Honors Program at the University of California, Riverside. He has received fellowships from the American Council of Learned Societies, the National Science Foundation, and the John Simon Guggenheim Memorial Foundation. He is the author of seven books, including *Economics: Mathematical Politics or Science of Diminishing Returns?* (1992), which secured the Lakatos Award in the Philosophy of Science for 1993. His newest book is *Instrumental Biology, or, The Disunity of Science* (1994).

Larry S. Temkin is Associate Professor of Philosophy at Rice University. He received his B.A. from the University of Wisconsin in 1975, and his Ph.D. from Princeton in 1983. He also studied at Oxford University, and has been a Visiting Professor at the University of Pittsburgh. He specializes in ethics and social and political philosophy, and his essays have appeared in *Philosophy and Public Affairs* and *Philosophical Review*, as well as in anthologies published by Cambridge University Press and Yale University Press. His book *Inequality* (1993) presents a new way of understanding inequality that challenges standard assumptions and has far-reaching implications. His current research focuses on the nature of the good and of practical reasoning.

Allen Buchanan is Grainger Professor of Business Ethics and Professor of Philosophy and Medical Ethics at the University of Wisconsin, Madi-

son. He has written numerous articles in ethics, epistemology, political philosophy, bioethics, and other areas of applied ethics, and is the author of *Marx and Justice: The Radical Critique of Liberalism* (1982), *Ethics, Efficiency, and the Market* (1985), *Deciding for Others: The Ethics of Surrogate Decision Making* (with Dan W. Brock, 1989), and *Secession: The Morality of Political Divorce from Fort Sumter to Lithuania and Quebec* (1991).

Allen W. Wood is Professor of Philosophy at Cornell University, where he has taught since 1968. He received his B.A. from Reed College and his M.A. and Ph.D. from Yale University, and has held visiting appointments at the University of Michigan and the University of California at San Diego. His interests center on moral and social philosophy and on German philosophy of the eighteenth and nineteenth centuries. His publications include *Kant's Moral Religion* (1970), *Kant's Rational Theology* (1978), *Karl Marx* (1981), and *Hegel's Ethical Thought* (1990).

Dan W. Brock is University Professor, Professor of Philosophy and Biomedical Ethics, and Director of the Center for Biomedical Ethics at Brown University, where he has taught since 1969. He earned his B.A. in economics from Cornell University and his Ph.D. in philosophy from Columbia University. He has published many papers in biomedical ethics, as well as in moral and political philosophy, and is the author of *Deciding for Others: The Ethics of Surrogate Decision Making* (with Allen Buchanan, 1989) and of *Life and Death: Philosophical Essays in Biomedical Ethics* (1993).

Elizabeth S. Anderson is Associate Professor and Arthur F. Thurnau Professor of Philosophy and Women's Studies at the University of Michigan, Ann Arbor. Her book *Value in Ethics and Economics* (1993) develops a pluralistic theory of value and explores the ethical limitations of markets through cases such as surrogate motherhood and cost-benefit analysis applied to environmental quality. She has written on equality and market socialism, democracy and social-choice theory, incommensurable goods, rational choice, and John Stuart Mill. She is presently conducting research in feminist epistemology.

Daniel M. Farrell is Professor of Philosophy and Chair of the Philosophy Department at Ohio State University. He has published widely in ethics, social and political philosophy, and the philosophy of law, including a series of recent papers on some of the moral and logical problems of deterrence in both domestic and international contexts. He is currently completing a book on these latter problems, in which he argues that deterrent threats and enforcements are justified (when in fact they are justified) not by their overall social utility but by their conformity to certain deontological principles for choosing among harms (or probabilities of harms) in various kinds of choice situations.

Thomas W. Pogge is Associate Professor of Philosophy at Columbia University. He studied sociology and philosophy at Hamburg University and Harvard University, and is currently teaching and writing mainly on Kant and moral and political philosophy, with a special emphasis on issues in global justice, human rights, and contractarianism. His most recent publications include *Realizing Rawls* (1989) and essays in the *Journal of Social Philosophy*, *Zeitschrift für Philosophische Forschung*, *Journal of Philosophy*, *Ethics*, and *Philosophy and Public Affairs*.

Michael Gorr is Professor of Philosophy at Illinois State University. He received his Ph.D. from Brown University in 1975, and is the author of *Coercion, Freedom, and Exploitation* (1989), as well as numerous articles in moral, political, and legal philosophy in journals such as *Philosophy and Public Affairs*, *Law and Philosophy*, and *Philosophical Quarterly*. He is currently working on a book on freedom of expression.

Baogang He is Lecturer in Political Science at the University of Tasmania. He received his Ph.D. from Australian National University, and is the author of more than a dozen English articles on political theory, Chinese politics, and Chinese political thought. He has worked on Chinese translations of a number of Western works, such as John Rawls's *A Theory of Justice*, and is presently working on the Chinese Transition toward Marketization and Democratization, a project funded by the Australian Research Council.
