

INSTRUCTIONS FOR AUTHORS

Epidemiologia e Psichiatria Sociale (EPS), established in 1992 by Michele Tansella, is an international, peer-reviewed journal for Epidemiology and Psychiatric Sciences intended to provide updated data and scientific information to epidemiologists, psychiatrists, psychologists, statisticians and other research and mental health workers primarily concerned with public health and epidemiological and social psychiatry.

Priority is given to original research and systematic reviews about mental health service research, aimed to improve the quality of everyday practice.

EPS in 2005 has been selected for coverage in Social Science Citation Index and Current Contents/Social and Behavioural Sciences.

EPS is published every three months (in March, June, September and December).

Besides **Original Articles** (no more than 4000 words, excluding structured summary, references, tables and figures; no more than a combined total of 7 tables and/or figures) and **Short Articles** (no more than 3000 words, excluding summary, references, tables and figures; no more than a combined total of 3 tables and/or figures) which report empirical findings, EPS publishes invited **Editorials** (no more than 3000 words, excluding references, tables and figures. A non-structured summary is required for Editorials) and invited **Special Articles** (no more than 4000 words, excluding structured summary, references, tables and figures; no more than a combined total of 7 tables and/or figures). Both invited Editorials and Special Articles are intended to keep-up with the changing world of epidemiological psychiatry and consider new perspectives.

The Editor will also consider **Methodological Contributions, Systematic Reviews and Meta-analyses** (no more than 4000 words, excluding structured summary, references, tables and figures; no more than a combined total of 7 tables and/or figures). Finally the Section named **Instruments** (edited by Professor Mirella Ruggeri) focuses upon scales, questionnaires and other assessment measurements, relevant to epidemiological psychiatric research.

Letters. This is not a Section for correspondence. Papers originally submitted as *Original Articles* may be revised by the Editor and external Assessors and accepted as letters (no more than 2500 words, excluding references; no more than a combined total of 3 tables and/or figures and no more than 20 references. A summary is not required).

Submissions by email attachments are preferred. Alternatively contributors who wish may send one hard copy of the text, tables and figures, plus an identical copy on computer disk, giving details of format used (e.g. MS Word etc.).

A covering letter should give full mailing, fax and email contact details of the author who will handle correspondence. Submission of a paper will be held to imply that it contains original work that has not been previously

published and that it is not being submitted for publication elsewhere. This should be confirmed in the letter of submission. When an article has been accepted for publication, the authors should email their final version or send a copy on computer disk (indicating format used, e.g. Mac/PC, MS Word/Word Perfect, etc.) together with one hard copy of the typescript and good quality copies of all tables, figures, etc. However, the publisher reserves the right to typeset the material by conventional means if an author's disk proves unsatisfactory. The papers published in EPS are protected by copyright and cannot be published elsewhere without written permission given by the Editor and the Publisher.

All contributions (excluding invited Editorials) are accepted for publication after external peer review.

■ MANUSCRIPTS

Submitted manuscripts must be either in English or Italian.

Manuscripts must be typewritten on one side of the paper in double-spacing with wide margins throughout, including references and notes, and all pages consecutively numbered.

Manuscripts in English

The following information must be given on the first page (title sheet): (1) title and short title for running head; (2) authors' names, (3) department(s) in which the work was done, (4) the name of an author to whom correspondence should be sent must be indicated and a full postal address (including phone and fax number, with an international code, as well as e-mail address) given in the footnote. Any acknowledgements should be placed at the end of the text. The second page of all manuscripts should contain a structured summary of the paper, (no longer than 250 words), subdivided into the following sections: *Aim* (main objectives of the work); *Methods* (data sources, criteria of inclusion/exclusion of reviewed papers, etc.), *Results* (most important findings obtained), *Conclusions* (that is directly supported by data). A non-structured summary (no longer than 250 words) is required for Editorials and no summary is required for manuscripts published in section *Instruments*. After the summary, please provide 4 *Key Words* (selected from those included in Thesaurus, PubMed) and a *Declaration of Interest*, in which Authors must declare:

- i. any grants and financial support received for the study;
- ii. any forms of financing (including pharmaceutical company support and any *honoraria* for consultancies or interventions received by each author in the last two years)
- iii. any other involvement that might be considered a conflict of interest in connection with the submitted article.

Manuscripts in Italian

The following information must be given on the first page (title sheet): (1) title and short title for running head (both in English and Italian); (2) authors' names, (3) department(s) in which the work was done, (4) the name of an author to whom correspondence should be sent must be indicated and a full postal address (including phone and fax number, with an international code, as well as e-mail address) given in the footnote. Any acknowledgements should be placed at the end of the text. The second page of all manuscripts should contain a structured summary of the paper (no longer than 250 words) (both in English and Italian), subdivided into the following sections: *Aim/Scopo* (summarise aims and objectives of the work);

Methods/Metodi (data sources, criteria of inclusion/exclusion of reviewed papers, etc.), *Results/Risultati* (most important findings obtained), *Conclusions/Conclusioni* (that is directly supported by data). A non-structured summary (no longer than 250 words) is required for Editorials and no summary is required for manuscripts published in section *Instruments*. After the summary, please provide 4 *Key Words* (in English, selected from those included in Thesaurus, PubMed) and a *Declaration of Interest/Dichiarazione di Conflitto di Interessi*, in which Authors must declare:

- i. any grants and financial support received for the study;
- ii. any forms of financing (included pharmaceutical company support and any *honoraria* for consultancies or interventions received by each author in the last two years)
- iii. any other involvements that might be considered a conflict of interest in connection with the submitted article.

All Manuscripts (in English and Italian)

Authors should follow carefully the following instructions:

- divide the manuscript into headings (e.g. for experimental studies: Introduction, Method, Results, Discussion);
- underline in the text words and phrases which should be printed in italics;
- use before decimals a dot rather than a comma (English style) both in the text and in tables and figures (e.g. 0.08);
- cite in the text only the references that are included in the reference list. For articles by a single author, provide the surname and year of publication (e.g.: Reissland, 2000). For the articles published by two authors, provide both surnames, with the symbol '&' between them and the year of publication (e.g.: Evans & Huxley, 2001). For articles by more than two authors, provide only the first name followed by *et al.* and the year of publication (e.g. Atkinson *et al.*, 1997).

If there is more than one reference by the same author(s) in the same year of publication, indicate this with letters a, b, c after year of publication both in the text and in the reference list (e.g.: Jones, 1999a; Jones, 1999b; etc.).

REFERENCES

At the end of the paper, all references should be listed according the Harvard style. Please follow the instructions below:

Journal articles and publications in press. All the authors must be listed. Indicate the surname(s) followed by the initials of each author, year of publication (in parenthesis), title of article (capital initial letter only for the first word of title), Journal name (not abbreviated and underlined), volume number, first and last pages.

Journal Supplement articles. After the author(s), year of publication and title (see above), indicate title of supplement (underlined, capital first letters for all the title's words), editors' initials, journal name (not abbreviated), supplement number, volume number, first and last pages (with symbol pp.).

Chapters from Books. After the author(s), year of publication and title (see above), indicate the title of the book (underlined, capital first letters for all the title's words), authors' and editors' initials, first and last pages (see above), publishers and place of publication (with colon).

TABLES AND FIGURES

Only essential figures and tables should be included. Tables should be numbered consecutively in the text in Roman numerals and each typed on a separate sheet after the References section. Titles should be typed above the table. In the text, tables must be cited without abbreviations (e.g. Table I). Figures should be numbered consecutively in the text in Arabic numerals and each typed on a separate sheet after the References section. Each figure should be followed by a legend (title). In the text, tables must be cited without abbreviations (e.g. Figure 1).

GUIDELINES FOR AUTHORSHIP

(International Committee of Medical Journal Editors. *Uniform requirements for manuscripts submitted to biomedical journals*. Philadelphia, PA: ICMJE, 1993)

"All persons designated as authors should qualify for authorship. Each author should have participated sufficiently in the work to take public responsibility for the content.

Authorship credit should be based only on substantial contributions to 1) conception and design, or analysis and interpretation of data; **and** to 2) drafting the article or revising it critically for important intellectual content; **and** on 3) final approval of the version to be published. Conditions 1, 2, and 3 must all be met. Participation solely in the acquisition of funding or the collection of data does not justify authorship. General supervision of the research group is not sufficient for authorship. Any part of an article critical to its main conclusions must be the responsibility of at least one author. Editors may ask authors to describe what each contributed; this information may be published.

Increasingly, multicentre trials are attributed to a corporate author. All members of the group who are named as authors, either in the authorship position below or in a footnote, should fully meet the above criteria for authorship. Group members who do not meet these criteria should be listed, with their permission, in the Acknowledgements or in an appendix.

The order of authorship should be a joint decision of the co-authors. Because the order is assigned in different ways, its meaning cannot be inferred accurately unless it is stated by the authors. Authors may wish to explain the order of authorship in a footnote. In deciding on the order, authors should be aware that many journals limit the number of authors listed in the table of contents and that the U.S. National Library of Medicine (NLM) lists in MEDLINE only the first 24 plus the last author when there are more than 25 authors."

FURTHER INFORMATION CONCERNING PAPERS ACCEPTED FOR PUBLICATION

Accepted papers will be sent back to the corresponding author by e-mail for corrections and answers to editorial queries. The manuscript should be revised and the final version sent by email to Dr. R. Fianco, Editorial Assistant.

The Publishers will send a final proof copy to the corresponding author. Off prints can be ordered when the final proof copy is returned.
