THE CONTRIBUTORS

WILLIAM M. FRANKLIN is Director of the Historical Office of the Department of State, with which he has been associated since 1947. He served as the principal editor of the special *Foreign Relations* volumes on *The Conferences at Cairo and Tehran, 1943*, and *The Conferences at Malta and Yalta, 1945*.

AMITAI ETZIONI is Associate Professor of Sociology and a staff member of the Institute of War and Peace Studies at Columbia University. Author of *A Comparative Analysis of Complex Organizations* (1961) and *The Hard Way to Peace* (1962), he is presently concerned with a comparative study of forces and leaders of political unification.

ZBIGNIEW BRZEZINSKI is Professor of Public Law and Government at Columbia University and Director of its Research Institute on Communist Affairs. Having published *The Soviet Bloc: Unity and Conflict* (1960) and *Ideology and Power in Soviet Politics* (1962), he is preparing a study on *Political Power: USA-USSR* with Samuel P. Huntington, to appear in 1964.

SAMUEL P. HUNTINGTON, formerly Research Associate at Columbia's Institute of War and Peace Studies, is now Professor of Government at Harvard University. His books include *The Soldier and the State* (1957), *The Common Defense* (1961), and *Changing Patterns of Military Politics* (1962).

HERBERT FEITH, Senior Lecturer in Politics at Monash University in Melbourne, was employed in Djakarta during 1951-1956 in the Indonesian Ministry of Information and has since revisited that country twice. He received a Ph.D. degree from Cornell in 1961 and published *The Decline of Constitutional Democracy in Indonesia* last year.

SUSANNE HOEBER RUDOLPH, Lecturer in the Department of Government at Harvard, has a study forthcoming that is entitled *Rajasthan in Transition: From Traditional to Modern Politics in India*.

GEORGE LISKA is Professor of Government at Wesleyan University. His latest book is *Nations in Alliance: The Limits of Interdependence* (1962).

KURT L. SHELL, from 1956 to 1961 Assistant Professor of Political Science at Harpur College, State University of New York, is now Research Associate at the Institut für Politische Wissenschaft an der Freien Universität in Berlin. The author of *The Transformation of Austrian Socialism* (1962), he is engaged in research on the reactions of the Berlin leadership and population to the erection of the Wall.

FRED W. RIGGS, Professor of Government at Indiana University, is Director of its Faculty Seminar on Political and Administrative Development and Acting Director of the International Development Research Seminar. His publications include *The Ecology of Public Administration* (1961) and *Administration in Developing Countries: The Theory of Prismatic Society* (forthcoming).

RICHARD J. BARNET, former Deputy Director of the Office of Political Research, U.S. Arms Control and Disarmament Agency, has become a Fellow and Acting Co-director of the Institute for Policy Studies in Washington. The author of *Who Wants Disarmament?* (1960), he is editing with Richard A. Falk a series of essays on inspection and compliance in disarmament agreements.
