

Contributors

Emily Abrams Ansari is an Assistant Professor of Music History at the University of Western Ontario in Canada. She received her Ph.D. from Harvard University in 2010. Her research considers the involvement of U.S. composers in Cold War cultural diplomacy campaigns and assesses the features of music that have encouraged governments to exploit it as a propaganda tool.

Walter B. Bailey is Associate Professor and Chair of Musicology at Rice University's Shepherd School of Music. He is the author of *Programmatic Elements in the Works of Schoenberg* (UMI Research Press, 1984), coauthor of *Radio Britain: A Bio-Bibliography* (Greenwood Press, 1990), and editor of *The Schoenberg Companion* (Greenwood Press, 1998). His articles have appeared in *American Music*, the *Journal of the Arnold Schoenberg Institute*, and the *Musical Quarterly*.

Gary R. Boye is Music Librarian and Associate Professor at Appalachian State University and holds degrees in classical guitar performance, library science, and musicology. He teaches music bibliography, guitar literature, and the history of country music. His research interests include early guitar and lute music, as well as twentieth-century popular music, especially country and bluegrass music.

Tim Carter, David G. Frey Distinguished Professor of Music at the University of North Carolina at Chapel Hill, works on music in late Renaissance and early baroque Italy, Mozart's operas, and Broadway musicals. He is currently producing a critical edition of Paul Green and Kurt Weill's *Johnny Johnson* (1936).

Joan DeVee Dixon, pianist and organist, is the author of the bio-bibliography of George Rochberg (Pendragon Press, 1992). In addition to her work with Rochberg, she has collaborated with Stephen Paulus, Carol Barnett, and Emma Lou Diemer in dozens of commissions, premieres, and recordings. Ryan Dohoney is a musicologist researching U.S. experimental music and culture since 1950. He received his Ph.D. in musicology from Columbia University in 2009. His book-in-progress is titled *The Illusion of Feeling: Morton Feldman and the Rothko Chapel*. He is a faculty fellow in the Music Department at Colby College.

Carol A. Hess teaches at Michigan State University. She has received the Society for American Music's Lowens Article Award, the ASCAP-Deems Taylor Award, and the Robert M. Stevenson Award for Outstanding Scholarship in Iberian Music (American Musicological Society) and has been twice been a Fulbright Lecturer

(Spain, Argentina). Among her books is *Manuel de Falla and Modernism in Spain, 1898–1936* (University of Chicago Press, 2001). She is currently completing a book on Pan Americanism and music in the United States.

Elizabeth Juliana Knighton holds a Master of Arts degree in Music History from the University of Washington. Her research interests center on the roles of women in instrumental performance in the early twentieth century. In addition to her academic work, Knighton teaches elementary instrumental music in the Seattle Public Schools, works as a coach for the Cascade Youth Symphony Orchestra, performs with the Northwest Symphony Orchestra, and maintains a private violin studio.

Brenda Leonard teaches cello and music theory at North Greenville University in Tigerville, South Carolina, and freelances in the Upstate area. She is nearing completion of a doctorate from the University of South Carolina, Columbia, where she studied with Robert Jesselson. Music for the unaccompanied cello is a particular area of performance interest, especially works of the twentieth century.

David Nicholls is a Professor of Music at the University of Southampton. He has published widely on music in the United States and is the author of two monographs, *American Experimental Music, 1890–1940* (Cambridge University Press, 1990) and *John Cage* (University of Illinois Press, 2007).

Ann van der Merwe teaches music history and appreciation courses in the Department of Music at Miami University in Oxford, Ohio, and is the author of *The Ziegfeld Follies: A History in Song* (Scarecrow Press, 2009). She holds a B.M. in voice from the University of Illinois and M.A. and Ph.D. degrees in musicology from The Ohio State University.
