## CONTRIBUTORS

**Jonathan Barnes** is a Fellow of Balliol College and Professor of Ancient Philosophy in the University of Oxford. He has held visiting posts at various universities in North America and Europe. His main professional interest is in ancient philosophy. His most recent publication is *The Toils of Scepticism* (Cambridge University Press, 1990).

**Annette Baier** is a Professor of Philosophy at the University of Pittsburgh. She has previously taught at Carnegie-Mellon University, the University of Sydney, the University of Auckland, and the University of Aberdeen. She studied at the University of Otago and Oxford University. She has published many articles in the philosophy of mind, ethics, and the history of philosophy, some of which are collected in her recent book, *Postures of the Mind* (University of Minnesota Press, 1985; Methuen Press, 1986). She is working on a book about David Hume.

**David Gauthier** is Distinguished Service Professor of Philosophy at the University of Pittsburgh. His most recent books are *Morals by Agreement*, in which he develops a rational, contractarian theory of morality, and *Moral Dealing*, a collection of his essays on the history of contractarian thought and on justice, rationality, and ideology. Previously, he wrote *The Logic of Leviathan*, a study of the moral and political thought of Thomas Hobbes. His current research interests are in understanding Rousseau as a critic of modern society, and in refining the maximizing conception of practical rationality.

**Michael Ruse** is Professor of Philosophy and Zoology at the University of Guelph. His research interests lie in the history and philosophy of biology, especially evolutionary theory. He is the author of a number of books, including *The Darwinian Revolution: Science Red in Tooth & Claw* (University of Chicago, 1979), *Taking Darwin Seriously: A Naturalistic Approach to Philosophy* (Basil Blackwell, 1986), and *Homosexuality: A Philosophical Inquiry* (Basil Blackwell, 1988). He is now working on a study of the concept of progress in biology. Ruse is a Fellow of the American Association for the Advancement of Science and of the Royal Society of Canada.

**Alex Rosenberg** is Professor of Philosophy at the University of California, Riverside. He is the author of *Microeconomic Laws*, *Sociobiology and the Preemption of Social Science*, *The Structure of Biological Science*, *Philosophy of Social Science*, and co-author of *Hume and the Problem of Causation*, as well as papers on ethics, biology, and economics in *Social Philosophy & Policy*. He has held Guggenheim, American Council of Learned Societies, and National Science Foundation fellowships.

**Richard A. Epstein** is James Parker Hall Distinguished Service Professor of Law at the University of Chicago, where he has taught since 1972. He has been the editor of the *Journal of Legal Studies* since 1981, and a member of the American Academy of Arts and Sciences since 1985. His books include *Takings: Private Property and Eminent Domain* (1985), *Cases and Materials on Torts* (4th ed., with C. Gregory and H. Kalven, Jr., 1984), and *Modern Products Liability Law* (1980). He has taught courses in civil procedure, contract, land development, property, torts (including defamation and privacy), jurisprudence, legal history, Roman law, and workers' compensation. He has written extensively in these areas, as well as in those of constitutional and labor law. Before joining the University of Chicago faculty, he taught at the University of Southern California Law School from 1968 to 1972. He is a graduate of Columbia College, Oxford University (Juris.), and the Yale Law School.

**Andrew Oldenquist** has been a member of the Ohio State University Philosophy Department since 1962 and an Associate of OSU's Mershon Center since 1981. He has written on ethical theory, action theory, theories of alienation, applied ethics, social and political philosophy, and the philosophy of education. His recent books include *Normative Behavior* (1983), *The Non-Suicidal Society* (1986), *Society and the Individual* (coedited with Richard Garner, 1989), and a forthcoming volume, *Alienation, Community, and Work* (coedited with Menachem Rosner). While at Munich University, he will work on a new book that integrates philosophical, biological, and cultural accounts of the origins and nature of morality.

**Christina Sommers** is an Associate Professor of Philosophy at Clark University. She has published several articles in the area of moral philosophy. She is the editor of *Right and Wrong* and the coeditor of *Vice and Virtue in Everyday Life*.

**Zbigniew Rau** teaches at the University of Texas at Austin, where he specializes in the politics of the Soviet Union and Eastern Europe. He was educated at the University of Lodz and received his Ph.D. from the Polish University in England. From 1985 to 1988, he was a Visiting Fellow Commoner at Trinity College, Cambridge University. Rau is currently completing the first Polish edition of Locke's *Two Treatises of Government* as

well as a book entitled *Contractarianism versus Holism : The Argument of Locke's Two Treatises of Government*. He has written several articles for *Political Studies* which present a liberal interpretation of the emergence and growth of civil society in Eastern Europe.

**H. Tristram Engelhardt, Jr.** holds an M.D. with honors from Tulane University School of Medicine (1972) and a Ph.D. from the University of Texas at Austin (1969). Dr. Engelhardt is a Professor in the Departments of Medicine and Community Medicine, and Member of the Center for Ethics, Medicine, and Public Issues, Baylor College of Medicine. He is editor of the *Journal of Medicine and Philosophy* and coeditor of the *Philosophy and Medicine* book series. He has authored over one hundred and forty articles, in addition to numerous book reviews and other publications. His most recent book is *The Foundations of Bioethics* (Oxford, 1986).
