
Notes on Contributors

Juliane Fürst is Senior Lecturer in Modern History at the University of Bristol. She has worked and published widely on many aspects of Soviet youth culture from the Stalin period to the time of stagnation. She is the author of the monograph *Stalin's Last Generation: Soviet Youth and the Emergence of Mature Socialism* (OUP, 2010) and the editor of *Late Stalinist Russia: Society between Reconstruction and Reinvention* (Routledge, 2006). She is the Principal Investigator of an AHRC project entitled 'Dropping out of Socialism', which looks at alternative cultures all across Eastern Europe and investigates their similarities, differences, mechanism and role in shaping late socialism. For the last seven years she has been on the Soviet hippie trail and is currently writing a book on her *Explorations in the Soviet Hippie Land*.

Deborah B. Gould is Associate Professor of Sociology at the University of California, Santa Cruz. She received her PhD in political science from the University of Chicago, and is the author of *Moving Politics: Emotion and ACT UP's Fight Against AIDS* (University of Chicago Press, 2009), which won the American Sociological Association's Distinguished Contribution to Scholarship Award in the Political Sociology Section and the American Anthropological Association's Ruth Benedict Book Prize in 2010. Her research, in the area of political emotion and contentious politics, pursues the following themes: political desire and political withdrawal; political imaginaries and their conditions of possibility; political hope and despair; solidarities and their fracturing; and activism as world-making.

Joachim C. Häberlen is Assistant Professor of Modern Continental History at the University of Warwick. He received his PhD from the University of Chicago in 2011. Before coming to Warwick, he was Postdoctoral Research Fellow at the Centre for the History of Emotions, Berlin. Among his publications are *Politik und Vertrauen im Alltag: Die Arbeiterbewegung in Leipzig und Lyon im Moment der Krise, 1929–1933/38* (Vandenhoeck & Ruprecht, 2013); 'Contesting the Political: Conceptions of the Political in the Working-Class Movements of Leipzig and Lyon during the Interwar Period', *Contemporary European History*, 22 (2013): 33–63; 'Between Global Aspirations and Local Realities: The Global Dimensions of Interwar Communism', *Journal of Global History* 7 (2012): 415–437. He is currently working on a project on

the radical left-wing politics of emotion after 1968 in West Germany, funded by an EU Marie Curie Career Integration Grant.

Adam Page is a Research Fellow at the Institute for the Advanced Study of Media Cultures of Computer Simulation (MECS) at Leuphana University, Lüneburg. At MECS he is working on planning and architectural discourses of reconstruction, social stability and survival in the cold war. He completed his PhD thesis, 'The Architecture of Survival: Planning the Future of Cities in the Shadow of Air War, Britain 1935–1952' in the History Department at the University of Sheffield in 2014.

Nikolaos Papadogiannis obtained his PhD in History from the University of Cambridge in 2010. From January 2012 to December 2013 he was an Alexander von Humboldt Foundation Postdoctoral Research Fellow, examining the making of young West German and Greek tourists in the 1960s and 1970s, at the Humboldt University of Berlin. He is currently a Visiting Scholar at the University of St Andrews. He has published on issues related to left-wing cultural politics, gender, mass consumption and youth cultures in international academic journals, such as the *European History Quarterly*, 'Between Angelopoulos and *The Battleship Potemkin*: Cinema and the making of young Communists in Greece in the initial post-dictatorship period (1974–1981)', and the *Journal of Modern Greek Studies*, 'Confronting "Imperialism" and "Loneliness": Sexual and Gender Relations among Young Communists in Greece, 1974–1981'. He has also co-edited a thematic unit, 'Complexities of "Europe"' in the *European Review* as well as a thematic issue in the *European Review of History* (forthcoming).

Eduardo Romanos is Ramón y Cajal Fellow in the Department of Sociology I (Social Change) at the Universidad Complutense de Madrid. His main research interests are in the areas of political sociology and historical sociology, with a particular focus on social movements and protest. His most recent publications include 'Evictions, Petitions and Escraches: Contentious Housing in Austerity Spain', *Social Movement Studies*, 13, 2 (2014), 296–302; 'Radicalization from Outside: The Role of Anarchist Diaspora in Coordinating Armed Actions in Franco's Spain', in Lorenzo Bosi, Chares Demetriou and Stefan Malthaner, eds, *Dynamics of Political Violence* (Ashgate, 2014), and 'Collective Learning Processes within Social Movements: Some Insights into the Spanish 15-M/Indignados Movement', in Laurence Cox and Cristina Flesher Fominaya, eds, *Understanding European Movements* (Routledge, 2013). He is also the co-editor with Hara Kouki of *Protest Beyond Borders: Contentious Politics in Europe since 1945* (Berghahn, 2011). Since September 2013 he has co-chaired the Research Network on Social Movements (RN25) of the European Sociological Association.

Jake P. Smith is a PhD candidate in the Department of History at the University of Chicago. He has received numerous grants, including the Berlin Program Fellowship, to conduct research on the spatial aspects and emotional geographies of urban activism in late twentieth-century European cities. He is currently writing

his dissertation, which examines the history of squatting and urban romanticism in West Germany.

Russell A. Spinney, PhD, is an independent historian and instructor at the Santa Fe Preparatory School, Santa Fe, N. Mex., USA, co-organiser of the Emotions Studies network for the German Studies Association, and founder of the EE Ford Summer Seminar Series on Emotional Landscapes in History. He is currently working on a book manuscript based on his PhD dissertation from Pennsylvania State University, entitled *The Nation in Peril? Rethinking how Fear Influenced Everyday Life and Politics in the Weimar Republic*. Publications include ‘Through the Sons of the Old Chiefs: Surveying Space, Identity and European-American Relationships in the “New Purchase” Territory (Centre County, Pennsylvania 1769–1778)’, in William Pencak, ed., *Pennsylvania’s Revolution* (Penn State Press, 2010), and ‘Fear, Courage and Civic Behavior in the Weimar Republic’, *Revue Suisse d’Histoire*, 61 (2011), 74–89.

Christophe Traïni is Professor of Political Science at the Institute of Political Science in Aix-en-Provence. His research focuses on the sociology of activism and collective mobilisation. He is the author of *Les Braconniers de la République: Les Conflits autour des représentations de la Nature et la politique* (Presses Universitaires de France, 2003); *La Musique en colère* (Presses de Sciences Po, 2008), *La Cause animale (1820–1980): Essai de sociologie historique* (PUF, 2001). He has also edited a volume of essays entitled *Émotions . . . mobilisation!* (Presses de Sciences Po, 2009).

Adam Zientek is Lecturer and Post-Doctoral Fellow in the Thinking Matters Department at Stanford University. He received his BA in History from the University of California Berkeley in 2004 and his PhD in History from Stanford University in 2011. His research focuses on the social history of the Western Front in the First World War. He is currently working on a manuscript titled *Wine and Blood: Alcohol, Morale, and Discipline in the French Army on the Western Front*, which investigates alcohol consumption among French soldiers during the war. He is also preparing an article titled ‘The Other Mutinies’, which investigates soldiers’ acts of collective indiscipline in French railway stations over the summer of 1917, and is the author of <http://www.mutinies1917.com>, a website that provides open access to datasets, social network graphs and transcriptions of archival materials related to the 1917 French army mutinies.

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Tara Zahra, tzahra@uchicago.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
