Ralph Miliband

What is the Marxist view of politics? Neither Marx nor any of his successors sought to define an over-all theory. Now, from a wide range of disparate material, Professor Miliband has reconstructed the main elements of the political theory and actual politics which are specific to Marxism. He highlights some of the problems and tensions left unresolved by earlier Marxists and discusses some live questions: how is a class defined in Marxism and how, in real political life, does it relate to other classes, to political parties, and to the state? What is meant by 'the dictatorship of the proletariat'? What are the differences between 'reform' and 'revolution'?

This book extends the theme of Raymond Williams's earlier work in literary and cultural analysis. He analyses previous contributions to a Marxist theory of literature from Marx himself to Lukacs, Althusser, and Goldmann, offers a systematic discussion of major theoretical problems, and develops his own approach by outlining a theory of 'cultural materialism' which integrates Marxist theories of language with Marxist theories of literature. £3.50
