## **Tort Reform and Related Proposals**

### **Annotated Bibliographies on Product Liability and Medical Malpractice**

Prepared for the American Bar Association Section of Insurance, Negligence and Compensation Law Special Committee to Study the Tort System  
by the American Bar Foundation

**Edited by Bruce A. Levin and Robert Coyne**

The annotated bibliographies on product liability and medical malpractice review the leading literature in the field so as to analyze the strengths and weaknesses of the present tort liability system. In addition to the usual research sources, the American Bar Foundation received research materials from lawyers, law professors, consumer groups, insurance companies, business associations, governmental agencies, congressional committees, and many other groups and persons.

While it was impossible to annotate each of the thousands of documents received, the resulting compilation is believed to represent the leading thinking in the field. The documents annotated include published materials, proposed legislation, and statistical studies made by governmental groups and business interests.

Entries are arranged alphabetically by author, then by year, then either alphabetically by title or by exact date (whichever seemed more significant). Additionally, the bibliographies are indexed by author and subject.

This initial study—believed to be the first of its kind in this country—fulfills these objectives:

1. To identify the complaints being made of the present tort liability system
2. To identify those persons or groups making these complaints
3. To identify the proposals being advanced to “reform” the system
4. To identify both those persons or groups making these proposals and those who are criticizing them

The American Bar Foundation, in keeping with its agreement with the American Bar Association’s Special Committee to Study the Tort System, researched and prepared the annotated bibliography with objectivity. The annotations do not, of course, represent the views of the annotators, the American Bar Foundation, the American Bar Association, or the ABA Section of Insurance, Negligence and Compensation Law and its Special Committee to Study the Tort System.


