Notes on Contributors

Hedley Bull is Professor of International Relations at the Australian National University, Canberra. He was educated at the Universities of Sydney and Oxford, and taught at the London School of Economics, where he was Reader in Strategic Studies from 1956–62. He has published widely in the fields of International Theory and Strategic Studies, and his most well-known contribution is *The Control of the Arms Race* (1962). He is currently a Visiting Fellow at All Souls' College, Oxford, where he is completing a major work on modern international theory.

Michael Kaser is Professorial Fellow and University Reader in Economics at St Antony's College, Oxford. He graduated from King's College, Cambridge, and has worked for the Ministry of Works and the Foreign Office in London, and also at the Institut Universitaire de Hautes Etudes Internationales in Geneva. He has published widely on Eastern European economics, and is shortly to publish *The Soviet Economy and East-West Trade*, and *Comparative Development Economics*.

A. I. Dawisha is currently a lecturer in International Politics at the University of Lancaster. He received his B.A. degree from Lancaster in 1971 and his Ph.D. from the London School of Economics in 1974. He has published a number of articles in the fields of foreign policy analysis and Middle Eastern politics. He is also the author of *Egypt in the Arab World: The Elements of Foreign Policy* (1976).

Barrie A. Paskins read Moral Sciences at Trinity College, Cambridge, and is at present Defence Lecturer in the Ethical Aspects of War in the Department of War Studies, King's College, London.
