## CONTRIBUTORS

**Jeffrie G. Murphy** is Professor of Philosophy at Arizona State University and has published numerous articles and books in moral, legal, and political philosophy, among them *Evolution, Morality, and the Meaning of Life*; *Kant, The Philosophy of Right*; and *Retribution, Justice and Violence*. He is the coauthor, with Jules Coleman, of *The Philosophy of Law: An Introduction to Jurisprudence*, and the editor of *Civil Disobedience and Violence, An Introduction to Moral and Social Philosophy*, and *Punishment and Rehabilitation*.

**Donald Regan** is a member of the law faculty and the philosophy department at the University of Michigan. He teaches constitutional law, and moral and political philosophy. His book *Utilitarianism and Co-operation* shared the Franklin J. Matchette Prize for 1979–1980. In 1985–86, on a Guggenheim Fellowship, he completed a monograph about the constitutional limits on state economic regulation and taxation. With that out of his system, he resumed work on a book tentatively titled *Prolegomena to a Theory of the Good: Two Essays on Moral Agency*.

**Philip Soper** holds a Ph.D. in Philosophy, as well as a law degree from Harvard University, and is Professor of Law at the University of Michigan Law School. He has published widely in the areas of legal, moral, and political philosophy. His recent book, *A Theory of Law*, was published by Harvard University Press in 1985.

**Richard A. Epstein** is James Parker Hall Professor of Law at the University of Chicago Law School and has published widely in the fields of legal philosophy and economic law. He is the editor of the *Journal of Legal Studies*. This book, *Takings: Private Property and the Power of Eminent Domain* was published by Harvard University Press in 1985.

**David Lyons** is Professor of Philosophy at the Sage School of Philosophy at Cornell University, as well as Professor of Law at the Cornell Law School. He has published widely in the fields of moral, legal, and political philosophy. His most recent book, *Ethics and the Rule of Law*, was published in 1984 by Cambridge University Press.

**Jules Coleman** is Professor of Law and Philosophy of the Social Sciences at the Yale Law School. He is the author of many articles on moral, legal, and political philosophy, and the coauthor, with Jeffrie Murphy, of *The Philosophy of Law: An Introduction to Jurisprudence* (Totowa, N.J.: Rowman &

Allanheld, 1984). He is currently completing one book on rational choice approaches to moral, political, and legal theory, and a second on the philosophy of tort law.

**Charles Silver** is a former Managing Editor of *Ethics: An International Journal of Social, Political and Legal Philosophy*, a Ph.D. candidate in political science at the University of Chicago, and a student of law at Yale. He is the author of "Negative Positivism and the Hard Facts of Life," *The Monist*, vol. 68 (1985), and "Utilitarian Participation," *Social Science Information*, vol. 23 (1984).

**Joel Feinberg** is Professor of Philosophy at the University of Arizona in Tucson, and has published widely in the fields of moral, legal, and political philosophy. *Offense to Others*, volume two of his four-volume work, *The Moral Limits of the Criminal Law*, was published in 1985 by Oxford University Press.

**Randy E. Barnett** is Associate Professor of Law at the Illinois Institute of Technology, Chicago-Kent College of Law. His most recent articles include "A Consent Theory of Contract," in the *Columbia Law Review*, "Pursuing Justice in a Free Society" (two parts), in *Criminal Justice Ethics*, and "Curing the Drug Law Addiction: The Harmful Side-Effects of Legal Prohibition," forthcoming in *Dealing with Drugs*, edited by Ronald Hamowy. He edited a recent symposium on "The Limits of Public Law" in the *Harvard Journal of Law and Public Policy*, and coedited the book *Assessing the Criminal: Restitution, Retribution, and the Legal Process* (1977).

**Anthony Kronman** is the Edward J. Phelps Professor of Law at the Yale Law School. He has taught for nine years, previously holding positions at the University of Chicago and the University of Minnesota. He holds degrees in law and philosophy from Yale, and did his undergraduate work at Williams College. Professor Kronman is the author of a book on Max Weber, and the coeditor of a casebook on contract law and a collection of readings on the economic analysis of contracts. He is presently working on a book on the nature of practical wisdom and its place in the practice and teaching of law.
