Susan Rogers contends that in the course of large-scale transformations communities often reproduce and strengthen distinctive cultural and social features. In showing how the specific identity of a community is reproduced rather than obliterated by modernization, the author reveals dialectical relationships between structure and change, history and culture, and the centralized nation-state and regional diversity.
