THE CONTRIBUTORS

ORAN R. YOUNG is Assistant Professor of Politics and a Faculty Associate of the Center of International Studies at Princeton University. He is an Associate Editor of *World Politics* and the author of *The Intermediaries: Third Parties in International Crises* (1967), *Systems of Political Science* (1968), and *The Politics of Force: Bargaining During International Crises* (forthcoming).

DAVID CHAPLIN, who is the author of *The Peruvian Industrial Labor Force* (1967), is Assistant Professor of Sociology and Ibero-American Studies at the University of Wisconsin.

EDWARD J. MITCHELL is an economist in the Economics Department of The RAND Corporation. In the past he has taught economics and econometrics at both the University of Pennsylvania and the California Institute of Technology. He is now working on a quantitative analysis of the Huk uprising in the Philippines.

JAMES L. PAYNE is Assistant Professor of Government at the John E. Andrus Center for Public Affairs of Wesleyan University. He is the author of *Labor and Politics in Peru* (1965) and of the forthcoming *Patterns of Conflict in Colombia*.

ROBERT JERVIS, Assistant Professor of Government at Harvard and Research Associate of the Harvard Center for International Affairs, is engaged in studies of signaling and perception in international relations.
