

Public Opinion and Congressional Elections

William N. McPhee and William A. Glaser, eds. Sheed & Ward. 326 pp. \$5. 95.

A collection of original research studies based upon data obtained in four regional surveys of the midterm Congressional election in 1950. The focus here is upon those factors contributing generally to the sources and formation of public opinion in an election, but studies of voting behavior in midterm contests and the "coattails" phenomenon, and reports of a computer model of voting behavior are also presented.

Foreign Policy Decision Making

Richard C. Snyder, H. W. Bruck and Burton Sapin, eds. Free Press of Glencoe. 274 pp. \$5.00.

An attempt at systematic analysis of factors at play in foreign policy decision-making, written by the editors, first appeared in 1954. It is reprinted here in company with a critical article, an application of the method, and a discussion relating the study of decision-making to other types of analyses of international politics.

American Diplomacy and Emergent Patterns

Kenneth W. Thompson. New York University Press. 273 pp. \$4.50.

A collection of addresses delivered at New York University which survey American ideas, institutions, and policies for their ability to provide "a text and workbook for the examination of theory and practice relating moral principles and the imperatives of successful foreign policy."

The Strangled Cry

John Strachey. William Sloan Assoc. 256 pp. \$4.50.

Selections from the writings of this British M.P. and former Labour Government minister include an evaluation of the literature of "reaction" based on the works of Koestler, Orwell, Whitaker Chambers and Pasternak, some examples of war writings, and a short essay on India. A final series of articles deals with men influential in this century in the areas of politics and economics.

The United States and the Common Market

Don D. Humphrey. Praeger. 176 pp. \$1.75.

"It can only be in the national interest of the United States to support a more open trading community as a basis for world order," concludes the author of this study, written in anticipation of the Congress' consideration of the 1962 Trade Expansion Bill. Emphasis is upon American trade policy—its past experience and its future prospects in relation to the European Economic Community.

The Christian in Politics

Walter James. Oxford University Press. 220 pp. \$5.00.

While the best efforts of Christians to exert a salutary influence on politics "are not unlike those of a man who bales a perpetually leaking boat," there is a role for the Christian in affairs of state, says the author. This role is examined in light of early roots of a Christian attitude toward politics, the example of some "consciously Christian politicians," and the writings of several modern theorists.
