# Criminal Law of East & Central Africa

By J. J. R. COLLINGWOOD, B.A.(Hons.) (Cantab.)

This is a discussion and explanation of the Penal Codes of Zambia, Malawi, Kenya, Uganda, Tanganyika and Zanzibar.

After an introduction, and chapters dealing with general principles and the rules of criminal responsibility and the parties to offences, the author goes on to discuss separately the main offences prescribed by the Codes. These are arranged under the headings: Attempts and Conspiracies; Offences Against Public Order; Offences Against the Administration of Lawful Authority; Offences Injurious to the Public in General; Offences Against the Person; Offences Against Property; Malicious Injury to Property; Forgery, etc. The definition of each offence is followed by an explanation and by suitable illustrations. There is also a synoptic table of the six codes.

The similarities of the six codes are far more significant than their divergencies, so that this sort of arrangement, besides providing the opportunities for a comparative study, is able to present a simple and straightforward exposition of the law which, whilst primarily directed at law students, will none the less be of assistance to practitioners, magistrates, police officers and all others who are concerned with the administration of criminal justice through East and Central Africa.
