This volume includes descriptive notices on sixty-four literary works written or compiled before the end of the Han dynasty. Three dozen leading scholars from the United States and Europe summarize the subject matter and contents, present conclusions regarding authorship, authenticity and textual history, and indicate outstanding problems that await solution. Each item is supported by lists of traditional and modern editions, commentaries, translations and research aids. The sixty-four notices total nearly five hundred pages, with additional appendices and a 34-page index of scholars. The Chinese made the world's first bronze chime-bells, which they used to perform ritual music, particularly during the Shang and Zhou dynasties (ca. 1700-221 B.C.). Lothar von Falkenhausen's rich and detailed study reconstructs how the music of these bells—the

This book shows that classic Chinese philosophy is as rational as Western approaches dealing with the problems of logic, epistemology, language analysis, and linguistic topics from a philosophical point of view. It presents detailed analyses of rational and methodological features in Confucianism, Taoist philosophy, and the School of Names as well as Mohist approaches in classical Chinese philosophy, especially in regard to ideas of valid knowledge.

The authors also provide new arguments against cultural relativism and antirational movements like religious fundamentalism that do not pay due attention to what all human beings have in common—to cultural universals.
