**The Politics of Economic Power

This book questions the notion that South Africa can exert effective political leverage over its economically dependent neighbors while itself remaining free of regional influences.

Ronald T. Libby maintains that the ruling parties and groups in every state in the region are to some degree able to manipulate the regional economy to serve their own domestic and foreign policy objectives. He argues that South Africa's ruling party, like the ruling groups of ten other countries in the area, is not exempt from the effects of policy changes made by its neighbors.
