ST AUGUSTINE'S HOSPITAL REPORT

DEAR SIR,

In Henry Rollin's utterly deplorable review of the St Augustine's Report (*News and Notes*, September 1976, pp 15-7), the most deplorable cut of all was the assertion that Dr Ankers 'comes out of this tragedy particularly badly'. This is simply not true. Dr Ankers' heroic and virtually lone struggle to expose the treatment of long-stay patients was entirely vindicated. People like Dr Ankers, whose compassion and sense of fair play make them pursue the truth with single-mindedness and perseverance, are not popular (or perfect), but it is rather sickening that Henry Rollin should, at this stage, challenge Dr Ankers' motives. I had hoped that the St Augustine's Report would create some constructive ripples throughout the mental hospital establishment, but judging by your reviewer's attitudes, such a hope is a very forlorn one.
