

# Literacy, Law, and Social Order

Edward W. Stevens, Jr.

In this provocative new study, Stevens draws upon legal theory and case law to examine the meaning of literacy in American society. Litigation concerning wills, deeds, financial documents, claims for workman's compensation, voting, and jury duty reveals the difficulties faced by illiterates as they engage in activities basic to a constitutional democracy. Stevens argues that, although judicial and civil authorities view illiterate individuals as social anomalies, they tend to force such individuals to function within the context of the literate majority. He explores the ways illiteracy hampers both personal expression and participation in the full range of social, economic, political, and ideological transactions available to Americans.

## **Property Law and Legal Education**

Essays in Honor of John E. Cribbet Edited by Peter Hay and Michael H. Hoeflich

Property Law and Legal Education is a tribute to the long, distinguished, and varied career of John Cribbet, the acknowledged "statesman" of American property law.

Cribbet began his forty-year tenure at the University of Illinois at Urbana-Champaign as a teacher and founding faculty editor of the University of Illinois Law Forum. Both in the classroom and in his research, he shared his expertise in a variety of specialized legal fields, including judicial remedies, civil procedure, and his first (and perhaps greatest) professional love, personal property. With co-author Corwin W. Johnson, Cribbet wrote the classic casebook on the subject: Cases and Materials on Property, and together they penned Cases on *Property.* Cribbet's own works—including a score of articles in law reviews—have ranged far and wide, from land use to condominiums to the esoterica of the old tenures.

Cribbet's former students and colleagues discuss various issues involved with property law—including gifts, nuisance, the American law of land use, and conflicts-of-law involving property—incorporating the themes that Cribbet passed on. Examining both the history of legal education and its current state, two essays trace the progress of the legal programs at two institutions with which Cribbet has had longstanding associations: the University of Illinois and the Bloomington Law School.
