# Restatement of African Law

In the past, courts, lawyers and legal scholars in English-speaking Africa have had to rely mainly on the writings of social anthropologists and the patchy reports of judicial proceedings for their information about African customary laws. There were few comprehensive analyses by lawyers in legal language of the customary laws which could be used either by the courts or by legal scholars.

Conscious of these needs, and the demands for action made both by governments and scholarly conferences, the London School of Oriental and African Studies initiated its Restatement Project in 1959. Through its research officers, and other scholars working in conjunction with the Project, the systematic examination of existing materials on African customary law, and field investigation in a number of areas, notably Sierra Leone, Ghana, Nigeria, Cameroon, Kenya, Tanzania, Zambia, Malawi, Botswana and Swaziland, was set in motion. Where possible, the Project has worked with and through the governments in the countries concerned; and a number of official Restatement schemes have been undertaken by African governments in conjunction with the Project and under the supervision of officers seconded from it or trained by it.

The first two volumes in the series are now published and are by Mr. Eugene Cotran. They deal respectively with the customary laws of Kenya relating to Marriage and Divorce (vol. 1), and Succession (vol. 2).
