A century ago, Vienna and Budapest were the capital cities of the increasingly unstable Austro-Hungarian empire and scenes of intense cultural activity. However, as Péter Hanák shows in these vignettes of fin-de-siècle life, the intellectual and artistic vibrancy common to the two cities emerged from deeply different civic cultures.

Hanák surveys the urban development of the two cities and reviews the effects of modernization on their cultural lives. In so doing, he paints a remarkable portrait of turn-of-the-century life in Central Europe. His focus on mass culture and everyday life offers important new insights into the cultural currents that shaped the course of the twentieth century.




