

Christopher Chowrimootoo is a Ph.D. candidate at Harvard University, completing a dissertation on the production and reception of Benjamin Britten's operas. He is currently a Visiting Research Associate at King's College London and the Edison Fellow at the British Library.

Ilias Chrissochoidis is Resident Scholar at the John W. Kluge Center at the Library of Congress and a 2010 ACLS Fellow. A Handel specialist and creator of the Handel Reference Database <<http://ichriss.ccarh.org/HRD/>>, he has also been involved in recent Wagner projects. In 2009–10 he was a Research Associate at the ESRC Centre for Economic Learning and Social Evolution (UCL).

Steffen Huck is Professor and Head at UCL's Department of Economics. A 2004 Philip Leverhulme Prize recipient, he has worked on the role of trust and fairness in competition as well as on bounded rationality and evolutionary game theory. In recent years, he has explored applications of game theory to opera and in July 2010 he co-organized with Sir Peter Jonas the first conference on the topic.

Delphine Mordey recently completed a three-year Junior Research Fellowship at Newnham College, Cambridge, working on music in Paris during the Franco-Prussian War and Paris Commune. She is currently Director of Studies in Music at Newnham College and Churchill College, Cambridge.

Klára Móricz is Joseph E. and Grace W. Valentine Visiting Assistant Professor of Music at Amherst College. She published *Jewish Identities: Nationalism, Racism, and Utopianism in Twentieth-Century Music* in 2008 and is presently editing a volume of essays on Arthur Lourié with Simon Morrison. She is co-editor of *Journal of Musicology*. Her recent article on Arthur Lourié's *The Blackamoor of Peter the Great* was published in this journal.

Nina Treadwell is Associate Professor of Music at UC Santa Cruz. Her research and publications focus on the experiential dimensions of performance and improvisation, with a particular emphasis on multi-media works. In 2008 she published the monograph *Music and Wonder at the Medici Court*. She is currently working on a new book project on fan videos (vids), tentatively titled '*Bad Girls*' and *Fannish Vidding: Musicking and the Dynamics of Relational Embodiment*.
