

By 1660, when the Spanish had converted the Inca Empire into a colonial society, imperial Inca religion had all but disappeared. At a

regional level, however, religious beliefs and practices that had thrived for centuries continued to express pre-Inca and Inca conceptions of cosmic and social order. Addressing problems of objectivity and authenticity, Sabine MacCormack reconstructs how Andean religion was understood by the Spanish in light of European theological and philosophical movements, and by Andean writers trying to find antecedents to their new Christian faith.

Guerrillas and Revolution in Latin America A Comparative Study of Insurgents and Regimes since 1956

Timothy P. Wickham-Crowley

In this comparative survey of guerrilla movements in Latin America, Timothy Wickham-Crowley explores the origins and outcomes of rural insurgencies in nearly a dozen cases from 1956 onward. Focusing on the personal backgrounds of the guerrillas themselves and on national social conditions, he explains why guerrillas have emerged strongly in certain countries but not in others. He demonstrates that the study of revolution in Latin America must combine society-centered analyses of the sources of insurgency with state-centered analyses of the strengths or weaknesses of the regimes being confronted.



NOTES FOR CONTRIBUTORS

Emphasis in comparative studies may be either on similarities or, if these are significant enough and call for some recasting of generalizations, on differences. Two copies of each contribution, preferably accompanied by a stamped, addressed envelope, should be submitted. Both text and footnotes should be clearly typed with double spacing and wide margins; footnotes should appear on separate pages at the end of the article. Illustrations may be included by arrangement with the editors.
