NOTES ON CONTRIBUTORS

JOCELYN ALEXANDER is a Senior Associate Member of St Antony's College, Oxford, and a Leverhulme Research Fellow. Her fieldwork in Manica Province, Mozambique, was done in 1993 and 1994; extended studies drawing on her research have been published in Maputo

DAVID B. COPLAN is now Professor of Social Anthropology at the University of Witwatersrand, Johannesburg, after teaching at the University of Cape Town for many years. In 1994 he published *In the Time of Cannibals* and in 1995 *Lyrics of the Basotho Migrants*. He has been working in Lesotho since 1978.

ROGER GOCKING teaches in the Department of History and Government at Mercy College in New York State. He has published mainly on aspects of legal practice in Ghana; in 1991–92 he was a Fulbright lecturer in Lesotho.

ANNELET HARTS-BROEKHUIS is a lecturer in the Department of the Geography of Developing Countries at the University of Utrecht. She and her students have been carrying out research in Mali since 1978.

KIRK ARDEN HOPPE is a member of the African Studies Center, Boston University. In 1994 he carried out field research in Uganda and Tanzania on communities around Lake Victoria

SONPIE KPONE-TONWE teaches in the Department of History at the University of Port Harcourt, where, in 1990, he completed his doctoral dissertation on the Ogoni.

TIM QUINLAN is a Senior Research Officer in the Institute for Social and Economic Research, University of Durban—Westville, and has worked in Lesotho since 1979. In addition to studies of chieftainship he has published on herding and grassland management in Lesotho and has made a video film on Basotho herders.

CHARLES TRIPP is Senior Lecturer in Politics with Reference to the Near and Middle East at the School of Oriental and African Studies, University of London. He is working on a study of Islamic responses to capitalism in Egypt since 1945.
