


JUST PUBLISHED



Over 300 judgments handed down by Israeli courts, particularly the Supreme Court, have been summarized by Judge Asher Felix Landau and published in *The Jerusalem Post's* "Law Report," which he has written since 1982. This volume contains selections from the weekly column chosen by members of the Harry and Michael Sacher Institute for Legislative Research and Comparative Law, which is associated with the Hebrew University of Jerusalem's Faculty of Law.
