

CONTRIBUTORS TO THIS ISSUE

DAVID CARPENTER is a Lecturer in History at Queen Mary College, University of London. He has written "The Decline of the Curial Sheriff in England 1194-1258," *English Historical Review* (1976), and "Was There a Crisis of the Knightly Class in Thirteenth-Century England? The Oxfordshire Evidence," forthcoming in *The English Historical Review*. Currently he is writing a biography of King Henry III for the Eyre Methuen Monarchs of England Series.

JOHN D. FAIR is Associate Professor of History at Auburn University, Montgomery. He is the author of *British Interparty Conferences, A Study of the Procedure of Conciliation in British Politics, 1867-1921* (Clarendon, 1980) and has published articles in *The English Historical Review*, *Albion*, *The Journal of Modern History*, *The Journal of British Studies*, and other periodicals. He is presently extending his research into political and constitutional issues of the 1930s and 1940s.

CLIVE HOLMES is Associate Professor of History at Cornell University. He is the author of *The Eastern Association in the English Civil War* (1974) and *Lincolnshire in the Seventeenth Century* (1980). He has also written a number of articles on the relationship between the central government and the localities in the early modern period, which is the subject of his continuing research.

PHILIP D. JONES is Associate Professor of History at Bradley University. He has written "British Military Reform During the Administration of Lord Grey, 1830-1834," *Albion* (1972) and "U.S. Antitank Doctrine in World War II," *Military Review* (1980), as well as numerous book reviews.

JOHN DAVID ROOT is Associate Professor of History at the Illinois Institute of Technology. His publications include "English Catholic Modernism and Science: The Case of George Tyrrel," *The Heythrop Journal* (1977), and "Science, Religion, and Psychical Research: The Monistic Thought of Sir Oliver Lodge," *The Harvard Theological Review* (1979). He is at work on a history of the Synthetic Society.

RICHARD M. SCHNEER was graduated from the University of Virginia and received a D.D.S. from Columbia University. His interest in imperial history began during World War II when he saw army service in India after the 1944 famine in Bengal. The article in this issue is derived from research for a book on British policy toward Spanish and Portuguese imperialism in South America.

PAUL SEAVER is Associate Professor of History at Stanford University. His book, *The Puritan Lectureships, 1560-1662*, was published in 1970, and an article on local Puritan politics appeared in *Albion* (1977). Currently he is working on a study of a London Puritan artisan whose life spanned the first half of the seventeenth century.

KATHERINE WYNDHAM received a Ph.D. from London University in 1976 and presently is working as an editor of historical manuscripts for the Public Record Office, London. She has lectured at Bedford College, London University. Publications include an article in the *Bulletin of the Institute of Historical Research* and she is preparing a study of crown land and its recipients in the West of England from the mid-sixteenth century to the early seventeenth century.
