

EJA Referencing Guidelines

The **Author-Date System** should be used for referencing in order to minimize the number of footnotes or endnotes. References in the text should be made within parentheses and include the surname of the author (unless the author already appears within the same paragraph), the publication date of the work and, where necessary, the page reference e.g. (Smith & Jones, 2012: 338–39); (Smith et al., 2015: 99); (Molloy, 2011: figs 1–3); (Molloy, 2011: fig. 2), (Dolphijn & van Tuin, 2012: Ch. 5), (Dolphijn & van Tuin, 2012: Chs 4–6)

Note: Multiple authors are chronologically listed; Multiple years are separated by a comma (e.g. Nadelkopf, 1888, 1893)

Contributions should be followed by an alphabetical list of **REFERENCES**, comprising only those sources actually cited in the text. Please include DOIs as live links.

Reference entries with more than six authors should be limited to the first six names plus et al.: Author 1, Author 2, Author 3, Author 4, Author 5, Author 6, et al. year.

US states use standard abbreviations in parentheses, not short forms. So:
Lanham (MD): AltaMira Press
Thousand Oaks (CA): Sage Publications

Publication titles including BC or AD should use small caps, as elsewhere.
